Minutes of the Regional Capacity building workshop 2

Mr. Marijan Cukrov welcomed all the participants of the Regional Capacity Building workshop, presented the agenda and explained the overall objective of the workshop.

He began the workshop by presenting the REIF project in general, giving the audience an overview of the project, its goals and the results achieved thus far. Next up he talked about the cooperation between KIP and the project established Regional Advisory board on drafting and now finalising the Roadmap “New rail infrastructure/services 2030”, as well as all documentation that preceded the Roadmap and was needed for its creation. He talked about the priority list of actions and how it is the basis for the Roadmap which will describe the actions and measures needed, describe the main steps for the implementation of the actions and measures, as well as select key stakeholders, define the timeframe of its completion, the estimated budget and the sources of financing.

After the presentation, the participants were given the opportunity to discuss their opinions on the newly founded Regional advisory board and what their work, in cooperation with KIP, could bring to the railway infrastructure in Croatia. The participants agreed that a lot of work needs to be done to ensure the railway infrastructure in Croatia is modernised, and that identifying and selecting frequently used lines located on important domestic and international railway corridors as the first lines to be modified is of utmost importance.

Mr. Cukrov agreed with the participants of the roundtable, and has ensured that careful selection of actions for the Roadmap has indeed been done with the help of the Advisory board. He gave a short recap of the workshop and thanked everyone for joining, and invited them to also participate in the next workshop which is happening immediately after.




