Meeting and involvements of mayors, city council member and city builder and BEG-responsible took place 19./20./21.01.21 took place.	
Expected effects and follow-up, findings/conclusions that will contribute to achieving further project results	- Findings:	
	Projections of images of 2-dimensional CO2 apocalypse clock on public buildings were discarded.	
	The set-up study of the 2-Dimensional CO2 Apocalypse Clock was found to be good.	
	Site visits and others with representatives of the city council and the mayor were carried out.	
	The Pfaffenhofen public utility company was approached as to whether certain locations were suitable with regard to electricity and media supplies. Documents were examined.	
	Because of vandalism, certain locations were ruled out.	
	At the end of the work, the Arlmühlen site was identified as a possible installation site for the CO2 Apocalypse Clock.
