2. Establishment of the stakeholders' group

Development Agency North organized two grop meetings through November 2020. Two meetings were organized so potential stakeholders could chhose a date that suits them more well. Both meetings were organized in Varaždin City Hall where the representatives of City of Varaždin were also present since they are also a project partner in this project. Those two meetings combined for more than 25 potential stakeholders in this project where all of them were presented with circular economy principles and good practices which continued with a simple presentation of CITYCIRCLE project and where they fit in. Each and every stakeholder then had a chance to represent themselves, their practices and to clarify their interest in being a CITYCIRCLE stakeholder.
