2. Establishment of the stakeholders' group

Group meeting - 1st CITYCIRCLE workshop: Transition to a circular economy in Kranj

As part of the European project CITYCIRCLE, a workshop entitled Development of the Circular Economy in Kranj was held on Thursday 16.1.2020 in the City of Kranj.

City Manager Bor Rozman said in his opening address that the transition from a linear to a circular economy is a necessity, not a choice, so it is time for a change. He emphasized the efforts of the municipality and





invited all participants to a responsible and sustainable management of natural resources for a better quality of life for all of us.

In the introduction, Nina Taylor from the E-Institute, who, in addition to Kranj Municipality, is a Slovenian partner in the CITYCIRCLE project, introduced the basic concept of a circular economy. In the following, Igor Kos, from the Wcycle Institute, described examples of good practice already practiced in Maribor and elsewhere in Europe.

The presentation of the CITYCIRCLE project followed, focusing on the goals and activities that will be implemented in Kranj over the next 3 years. Project team at MOK, composed of Marija Ahačič Premrl, Uroš Kavdik and Aleksandra Ažman, is responsible for the implementation of the project in the Municipality of Kranj.

In addition to maintaining the environment and better use of space, the project team recognized the potential in which the competitiveness of business locations and the way to effectively deal with the degraded areas, while there are few bigger degaded areas in Kranj. At the same time as the need for new building land was on the rise, so was land space recognized as a finite natural resource.

The goals we want to achieve are: establishing a supportive information environment, creating a team of designers made up of various representatives of the local environment, who will work together in the team for development of the circular economy in Kranj, as well as raising public awareness and involvement. We all are responsible for a successful transition, so the participants were invited to participate in the discussion and through it the efforts of the municipality were confirmed; we all want to cooperate and make changes today to establish healthy environment in the future.

We conclude with the thought that each path begins with the first step and the awareness that with each step, even a small one, we will achieve something bigger and better.

Another project was CLEAR project which aims to serve as a kick-start mechanism for generating a better attitude towards Cultural Values (CVs), rendering them accessible to all and so seen as assets to local development. City of Kranj also worked on few very successful investment projects. Investing in communal infrastructure through GORKI project. Through project "Vodovod Bašelj Kranj" an intention was to assure the city with better water supply. Another coofinanced projects: PANGEA, REAAL, projects regarding energy renovation of buildings, other regional projects, etc.
