You are reading the 2nd Newsletter of **HealingPlaces** project.

In this issue we want to give you an overview of what happened in the life of the project during the second semester (1 October 2019 - 31 March 2020). As you may know from the 1st issue of our Newsletter within the next three years HealingPlaces project is and will be working on:

- construction of a common, innovative and web-based tool for assessment of threats and pressures on mineral and hot waters deposits in partners regions
- implementation of pilot actions in each region
- development of an integrated strategy for SPA sustainable development
- elaboration of an environmental assessment tools, specifically dedicated to SPAs and easy to use, guidelines and trainings will improve the capacities of public authorities and other SPA decision makers to act more effectively on the existing SPA development problems and usage conflicts through integrated environmental management approach.

In the 2nd semester the focus was mostly on the first two of points mentioned above.

PILOT ACTIONS

In the second period of Healing Places, activities in the pilot areas have been started and are at the beginning currently. For some partners, the main focus of this period in the pilot actions is on including stakeholders and establishing cooperation with project partners. There have been several activities in addressing relevant stakeholders.


For instance, in **Slovenia** partners have established further contacts with relevant stakeholders for their inclusion into the regional working group. Furthermore, the partners established contact and joined a Regional Working Group from project AQUARES* where the stakeholders deal with water reuse in Slovenia (more about cooperation - can be found under "events").

In addition, in November 2019 the project team attended a conference of Regional Development Agencies where project activities with other regions in Slovenia and identified key stakeholders, sources and best practices for better implementation of project activities were discussed. Finally, the Slovenian partners have also presented and discussed project activities with one spa municipality in their region and motivated them to involve actively in the project.

Also in **Austria**, presentations and meetings with regional stakeholders took place. The Austrian partners met with representatives of a SPA municipality, the health resort and several tourism associations. In addition, the project was presented to various regional and local entities (Chamber of Commerce, county of Upper Austria, regional providers).



Furthermore, two more regions in Upper Austria have been contacted to be part in the Healing Places project.



Czech Republic started first actions regarding their pilot action. In a first step, the geographical extension of the potential area of influence for pilot mineral water deposit was determined.



Work is currently underway to identify the most important actors and social groups for these regions and to diagnose and describe the influence and decision-making powers of the administration, business and public sector.

The Italian partners have concluded preparations with the local stakeholders and associates to share the purpose of the immersive room and to start the process of jointly finding the best location for the





immersive room. The aim is to locate the immersive room in Abano or Montegrotto in cooperation with two local municipalities and Consortia of Municipalities and Municipality of Padua. Currently the creation

of immersive room/museum of thermal baths connected with the national Museum of Padua to be able to attract a wider number of visitors/stakeholders is under discussion.

The Hungarian project partners have also started to organise the pilot actions in their regions by identifying and shortlisting the potential members of the Regional Working Groups in both counties. In order to build sustainable partnership on shifting towards nature-focused development of spa water potential, the right and most relevant stakeholders were selected and consulted.



To ensure that all key players are invited, several occasions are used to communicate and engage the relevant actors. On 11 December 2019 the Hungarian partners participated in the regional stakeholder platform meeting of InnovaSpa project* where HealingPlaces Hungarian pilot action objectives have been introduced and shortly discussed with participating stakeholders (most of them were also invited to be member of HealingPlaces regional working group).

KNOWLEDGE

One of the very important activities within HealingPlaces project implementation has been collecting and systematizing the knowledge about existing good practices and - especially - about possible synergies with other - past or on-going European projects founded from public funds, to ensure exchange of knowledge, when possible.

The results of the screening of existing good practices and approaches to solving SPA needs for sustainability - including solutions on international scale, as well as regional or trans-national examples of cooperation has been structured in the form of

a short database - accessible to all project partners - and divided into 4 main catalogues, such as: Valuable sources, Projects, Literature and Tools.

The "Projects" catalogue presents information about thematically related projects implemented on a national and international scale. About the cooperation with on-going project, you may see more under "events"

The next database catalogue "Valuable sources" contains a list of valuable and reliable sources from which HealingPlaces project, as well as all people interested in SPAs sustainable development and resources protection can benefit from. For example, we would like to encourage you to read the results of a very interesting study prepared in 2017 for Committee on Transport and Tourism (TRAN) - Health tourism in the EU: a general investigation*.

The study defines and explores SPA tourism as one of main components of Health Tourism with medical and wellness (together tourism), presenting interesting case studies and showing how increasing the share of health tourism may reduce tourism seasonality, improve sustainability and labour quality, and may help to reduce health costs through prevention measures.

Almost thirty people, representatives of project partners and one associated partner, took part in three days discussions and workshops. During the three day workshop the following topics were discussed:

Representatives of Development Centre Novo Mesto attended a round table on the topic of water reuse in Slovenia. During consultation, experts from different fields presented how to achieve sustainable management of water resources. More than 45 participants, together with the lecturers, discussed the needs for water reuse, what are main obstacles to circular water management and where are the opportunities for more sustainable water management in Slovenia.
