Short Description / Summary

The conference was held as a part of regular meeting of mayors from Hranice region. From the total number 31 of towns/villages were only 14 mayors physically presented during the conference.

The program related to Smart Commuting project was called “Smart and green solution for your route”. We wanted to present projects from the second part of our PUMM (planned activities), especially projects we will address projects related to transport connections of municipalities and the town of Hranice.

During the conference was presented complete SUMP by the company UDIMO, which was the main processor of Hranice SUMP. Mr. Macejka from UDIMO explained that the plan covers all modes and forms of transport throughout the territory, including public and private transport, passengers and freight, motorized and non-motorized, moving and parking. The proposed measures lead to improved transport safety, reduction of air pollution, noise, energy consumption, improved efficiency of transport of people and goods, contribute to strengthening the attractiveness and quality of the urban environment and territory, especially for the benefit of citizens.

All the mayors were involved in the fruitful discussion at the end of the presentation.

Links to deliverables and outputs

The main deliverables connected to our conference is Hranice SUMP.

Expected effects and follow up

We wanted to more involve all the mayors into the preparation process of SUMP, explain its necessity and the follow up. It is always hard to “catch” the mayors from smaller municipalities and explain them that this plan (SUMP) is not only about Hranice but about the whole region.
