Summary description of the implemented training measure(s), explaining the specific goal(s) and target groups

The additional training on Management plan development was held on 5. March 2019 in Jaworzno, Poland. Altogether 10 participants were trained.

Effective training activities were conducted in order to provide the necessary understanding and information as well as to engage actively participants in the training. Prior to the training, the local partners distributed to all participants the documents on Management plan for Jaworzno and themes of interest. Then the trainer gave the evaluation of the documents according to defined criteria (completeness, clearness and comprehensibility, focus on strategic objectives and forma requirements). Afterwards, local partners from Jaworzno presented their expertise in Management plan development. Finally, an active discussion about Jaworzno case study was performed, concrete suggestions for problem solving were defined. The discussion allowed exchange of transnational experience and knowledge.

The presented training supported the project partner to better understand the methodology and to finalize the groundwater Management plan.

Higher education and research (LP) and local public authority (LP2) were targeted groups involved in the training, since they are the responsible for the development and application of the Management plan.

Expected impact and benefits of the trainings for the concerned territories and target groups

The training was specially tailored according to local needs and challenges of the pilot in Jaworzno. The Management plan for Jaworzno was discussed; themes of interest were defined by local partner and distributed prior to the training. The training gave valuable suggestions for further steps, which shall improve the efficiency of working process.

This training methodology proved to be an adequate for thoroughly discussing and evaluating the Management plan. In this way, the partner successfully finalized Management plan, based on the instructions gained at the training.

Applied training measures were efficient and successful in reaching the set goals of this training. Combined measures of lecture style and interactive approach gave satisfactory results. The participants discussed Jaworzno case study, jointly suggesting solutions and exchanging experiences. Therefore, the working process of local partners shall be improved in future.
