

TRAINING ON MANAGEMENT PLAN DEVELOPMENT IN ZADAR

Summary description of the implemented training measure(s), explaining the specific goal(s) and target groups

The additional training on framework and background of the management plan was held on 5th September 2017 in Zadar, Croatia. Altogether 10 participants were trained.

Effective training activities were conducted in order to provide the necessary understanding and information as well as to engage actively participants in the training. Firstly, a trainer demonstrated his expertise in management plan development and provided information about the work plan. Secondly, a representative of the University of Zagreb reported about activities performed, followed by discussion about Zadar case study and corresponding problem solving. The discussion allowed exchange of transnational experience and knowledge. The presented training supported our project partner to better understand the methodology and initially to establish the framework and background for a groundwater management plan. The specific goal of the training was to provide to participants the necessary knowledge and specific practical examples on development of the management plan for Zadar. The participants were assisted in (i) defining their project scope and goals, (ii) delineating their functional urban area (FUA), (iii) defining target groups to be addressed and (iv) establishing and organizing their regional implementation group (RIG).

Higher education and research (PP11) and infrastructure and public service provider (PP12 and AP15) were targeted groups involved in the training, since they are the responsible for the development and application of the management plan.

Expected impact and benefits of the trainings for the concerned territories and target groups

The training was specially tailored according to local needs and challenges in Zadar. Project partners PP11 and PP12 have less experience in dealing with groundwater contamination, thus an additional training was organized in local Serbo-Croatian language. This offered the opportunity to present the project and discuss the goals as well as challenges on local language. Enabled contribution of more participants on a local level and their inclusion in the project is considered as a special benefit of the training.

Representatives of relevant institutions were invited to the RIG-local workshop, where experiences gained from the training were further transferred. The questionnaire on local experiences and needs was given to the participants. The concept of the management plan for Zadar was discussed. The training gave valuable information about the structure of the report, the criteria for delineation of FUA and definition of goals, which shall improve the efficiency of working process.

Sustainability of the training(s) and developed training material(s) and their transferability to other territories and stakeholders

This training methodology proved to be an adequate initial step to establish the framework and background for a groundwater management plan in the pilot Zadar. The presentations, discussions and material were performed on local language, which enabled an involvement of crucial parties for the development of the management plan. In this way, the partner shall be able to successfully develop a framework and background of the management plan, based on the instructions gained at the training.

A day after the training, a RIG-local workshop was held in Zadar, whereby the general concept was transferred to other stakeholders.

Lessons learned from the development and implementation of training measures and added value of transnational cooperation

Applied training measures were efficient and successful in reaching the set goals of this training. Combined measures of lecture style and interactive approach gave satisfactory results. The participants discussed Zadar case study, jointly suggesting solutions and exchanging experiences. Therefore, the working process of PP11 and PP12 shall be improved in future.
