1. Introduction





The deliverable T2.2.1 belongs to the activity related to the downstreaming past ICT Downstreaming past ICT EE financial and decision support tools (A.T2.2). Downstreaming actions include, beside tools adjustment, also possible data collection in the Pilot Actions (PAs) interested in such tools.

The Good Practice Register under TARGET-CE will be adapted and implemented into the OnePlace platform, containing all the tools implemented as part of the project. Accordingly, the good practices will be adapted and imported to the newly created tab on the OnePlace platform indicating good solutions in the field of energy efficiency. Additionally, according to D.T1.2.6, additional good practices will be collected among the project partners. The good practices gained during the EMPOWER project will be used and passed on to target groups during the training sessions.

2. Good Practice Register – short description

Good Practice Register is a database of 35 good practices from all Project Partners on the subject of Energy monitoring and financial instruments.

Good practices presented in the "Good Practice Register" are classified according to the type of good practice. These types include:

- 1-Good Practice measurement (hardware)
- 2-Good software
- 3-Good financial tools
- 4-Good organisation and management
- 5-Good data (energy and/or financial) collections system
- 6-Good energy and/or financial indicators and/or ergonomy
- 7-Good data analyzing system
- 8-Good use of data

The main goal for this catalogue was to have vademecum of good examples for all regions to import and implement in their areas. It works on the exchange of good practices on dynamically monitoring energy efficiency in buildings, with special focus on the use of innovative financial instruments, in order to achieve more carbon reduction and to improve low-carbon economy policies.

These good practices stimulate the development of new projects that innovate by applying cost-effective energy monitoring to reduce energy demand, using new technology.

3. Adaptation and integration of Good Practice Register to OnePlace Platform



At the time of implementing the Good Practice Register, the register of good practices implemented under the BOOSTEE-CE project is already available on the OnePlace Platform. In order to properly use and locate the good practices from the EMPOWER project, it was decided not to change the currently available presentation of good practices. Therefore, the good practices gained in the project will be adapted to the current form.

The method of navigating on the OnePlace Platform (https://oneplace.fbk.eu/) in order to gain access to the catalog of good practices is presented below:


1. MAIN PAGE -> ENERGY EFFICIENT CITIES








2. ENERGY EFFICIENT CITIES -> Search Database







3. Search Database Engine



Clicking on chosen practice we can receive information about it which is:

- Title of the Good Practice
- Location
- Benefits
- Implementation year

All these information will be accessible for every Platform host for every new chosen and added Best Practice.

In case of the Good Practices already input in the database – the structure of information is different than for those which are included in EMPOWER Good Practice Register. As stated above, the EMPOWER good practice information should be converted into the current format of the Good Practices database on the OnePlace Platform. To this end, a form was developed for 35 good practices to highlight relevant data. At this moment the structure of data in Good Practice Register is not similar to the structure presented in One Place database. Beneath is presented the original information form from EMPOWER project.

All pilot actions carried out in the project related to energy monitoring will be added to the register of good practices on the OnePlace Platform.
