1. Introduction

The deliverable D.T3.1.1 belongs to the activity related to the adjustment of strategies, roadmaps and action plans (A.T3.1), with the aim to capitalized non-technical EE solutions, provided by the selected transnational projects.

The BOOSTEE-CE outcome "Transnational Energy Efficiency Financing Strategy", included in the Strategy O.T4.2 "EE financing roadmaps for public infrastructures" has being adjusted and tailored in a way that they can be easily used and better deployed in the new PAs, on national, regional or local levels. The obtained results will be available through the (BOOSTEE-CE) OnePlace platform.

2. BOOSTEE-CE – Description

The Transnational Energy Efficiency Financing Strategy of the BOOSTEE-CE project was developed based on the Comparative analysis of financial schema and Transnational methodological framework for a roadmap development, showing how to look for, find and adopt different financing solutions for EE improvement.

The Transnational strategy for EE financing in CE defines, structures and reviews the existing energy financing solutions and models that are or will be in the future the important enablers for EE and energy savings in public infrastructures. The strategy assesses the potential of different financial models and gives recommendations.

The strategy assists partners and other stakeholders from partner countries to:

- Identify financing instruments (FI) that have never been used, assess its potential (based on legal framework, available capacities, market potential etc.) and propose measures for their implementation
- Propose improvements in existing financial instruments and models to improve their usage
- Assess opportunities and barriers to deploy financial instruments and models successfully used in other partner countries/regions and propose measures for their uptake.

2.1 Transnational Energy Efficiency Financing Strategy – Adaptation to new pilot areas

The financial sources for energy efficiency were reviewed and updated (where necessary) to new regulations existing in each country of the TARGET-CE partnership. The table below presents the changes for each financial source in each country with respect to BOOSTEE-CE outcomes.

Funding leveraged by ESIF			
	At the moment (in 2021) the value of works performed amounts for approx. 95%. The full amount of allocation is the same as was indicated in the original document.		
POLAND	In 2020 a new call for applications for co-financing under Activity 4.2 was opened in Mazovia Region. At this point, the allocation amount used to improve energy efficiency in this measure amounts to PLN 113 million (EUR 25 million). It is expected that for the purposes of thermal modernization, approximately PLN 80 million (EUR 17.5 million) will be additionally spent.		
	It's planned to fully use fundings in ESIF and obtain value of works performed equal 100%. Mazovia Region and Lower Silesian Voivodeship are close to executing the next Operational Programme (RPO WM 2021-2027). At the moment the full project of the Programme is published but it's still in the consultation phase.

2.2 "Transnational Energy Efficiency Financing Strategy – Problems occurred in capitalization

The financial sources in each country were checked and updated by project partners accordingly. Still some financial programmes are not published (such as Operational Programme) therefore the allocation to the priority axis is not known.

3. Results and examples of tailored tool in new PAs

The tailored "Transnational Energy Efficiency Financing Strategy" will be used in new TARGET-CE's pilot areas. The information will be placed within the OnePlace platform to the report changes in financial sources.

4. Conclusions
