nZEB AS A CONCRETE AND AFFORDABLE SOLUTION FOR PUBLIC BUILDINGS

From the first January 2019 in EU, public buildings have to achieve the nZEB target as required by EPBD (European Directive 2010/31/EU). eCentralproject invites Slovenian, Croatia and Hungarian public representatives to participate at the "coffee with mayor" events organized to present the opportunities and the supports offered at public authorities to achieve the nZEB target in new and renovated existing buildings.

Ravno zaradi tega ostaja velika mera skepticizma do novih finančnih mehanizmov, ki izhajajo iz njihovega nepoznavanja in zapletene administracije. Ne glede na to na vseh treh področjih obstajajo primeri uspešnih praks in uspešno izpeljanih projektov, ki v prihodnosti nakazujejo na izboljšave in ustrezno ureditev the področjih, četudi ta razvoj ostaja počasen.

GREEN PUBLIC PROCUREMENT IN ITALIA

I Green Public Procurement sono stati recepiti in Italia con il PAN GPP, che ne definisce gli obiettivi nazionali, le categorie di beni, servizi e di lavori per gli impatti Criteri Ambientali Minimi (CAM). Secondo il Codice degli appalti (D.lgs. 50/2016, aggiornato con D.lgs 56/2017), i CAM sono requisiti ambientali obbligatori volti a individuare la soluzione progettuale, il prodotto o il servizio migliore sotto il profilo ambientale lungo il ciclo di vita. I CAM in vigore sono 18 per diversi settori, tra cui l'edilizia. Per ogni criterio ambientale sono definiti i requisiti minimi e le modalità di verifica degli stessi.

NACHHALTIGE ÖFFENTLICHE BESCHAFFUNG IN ÖSTERREICH - AKTUALISIERUNG DES AKTIONSPANS

Österreich aktualisiert Aktionsplan für nachhaltige Beschaffung 2018. Bereits seit 2010 gibt es einen österreichischen Beschaffungspfad für nachhaltige Beschaffung. Darin sind Beschaffungsgruppen sowie Kriterien für einen umweltfreundlichen öffentlichen Einkauf definiert. Das Bundesministerium für Nachhaltigkeit und Tourismus hat im November verkündet, dass dieser Aktionsplan bis Ende 2018 aktualisiert wird und damit auf geänderte Rahmenbedingungen eingehen soll (z.B. Beschaffung Elektro-Autos für Fuhrparks).

GREEN PUBLIC PROCUREMENT (GPP) IN EUROPE

Europe's public authorities are major consumers. By using their purchasing power to choose environmentally friendly goods, services and works, they can make an important contribution to sustainable consumption and production. This is called Green Public Procurement (GPP) or green purchasing.

The EU member states developed National Action Plans on Green Public Procurement, where they set goals on sustainable purchasing and measures for implementing a green public procurement market.
